





Italy's Incentives for Foreign Productions

Tax Benefit: Italian Tax Credit

The incentive is for
**FOREIGN FILMS AND
AUDIOVISUAL SERIES** to be
shot in Italy and which pass
a cultural test

- IT ALLOWS A SAVING OF 30% ON PRODUCTION COSTS PAID BY THE ITALIAN EXECUTIVE PRODUCER
- TAX CREDIT IS BASED ON THE PRODUCTION EXPENSES INCURRED IN ITALY THAT DON'T EXCEED 75% OF THE TOTAL PRODUCTION BUDGET
- EXPENSES INCURRED IN ANY EU COUNTRY CAN BE INCLUDED IN ITALIAN EXPENSES UP TO A MAXIMUM OF 1/6 OF THE 75% TOTAL PRODUCTION BUDGET
- NO CAP PER PROJECT. MAXIMUM CREDIT AVAILABLE OF 20 MILLION EUROS EVERY YEAR
- CREDIT IS USED TO OFFSET ANY TAX DEBT



How to apply?

1 The ITALIAN COMPANY, registered on the MINISTRY'S PORTAL (DGCOL) must submit the project , together with the following info:

- General information on the project
- Production structure
- Financial Plan
- Italian Spent Budget

2 The ITALIAN COMPANY applies for a PRELIMINARY TAX CREDIT APPLICATION, which includes a cultural eligibility test to be passed with a minimum score



Within 30 days, the Ministry notifies on outcome of the CULTURAL ELEGIBILITY and APPROVAL FOR the PRELIMINARY TAX CREDIT

3 It allows the opportunity of using the earned TAX CREDIT from the 10° day of the FOLLOWING MONTH

Within 180 days after from the end of production activities

4 ITALIAN COMPANY makes the FINAL TAX CREDIT APPLICATION submitting a certified cost report

Possible adjustment of the final assesstment can be made with a maximum increase of 10%





Regional Funds

FABULA PICTURES has built a close and strong relationship with Italian Regional Film Commissions.

Films Commissions have set up Film Funds, with one/two calls in per year and other Benefits, such as Production Assistance which may be required any time of the year, for Italian and Foreign Companies allowing the promotion of the Italian territory.
